residential property(ies). In case of any dispute, the Vendor reserves its right to allocate any specified residential properties to any interested person by any method (including balloting).

The Vendor reserves the right to close the Sales Office at any time if all the specified residential properties have been sold out. For the safety of interested persons and maintenance of order at the Sales Office, the Vendor reserves its absolute right, in the case where a Tropical Cyclone Warning Signal No. 8 or above or Black Rainstorm Warning is in force in Hong Kong or an announcement on "extreme conditions" is made by the Government of the Hong Kong Special Administrative Region, to postpone, extend and/or change the date, time and/or place of the sale of specified residential properties to such other date, time and/or place as the Vendor may consider appropriate. Details will be announced on the website designated for the Development. Interested persons will not be notified separately.

The Vendor does not accept any person interested in purchasing the specified residential properties having queued up before the commencement of time of the sale on any date of the sale concerned.
